## 2024 Host Partner: Qatar National Library

The 2024 Annual Forum will be hosted in Doha, Qatar, with the Qatar National Library as our host partner.

Reflecting our emphasis on accessibility and inclusivity, the Annual Forum will be hybrid and offer online access to delegates unable to join us in person (together with a full day of online-only panel sessions). Meanwhile the in-person (and hybrid) portions of the Annual Forum will be hosted in the beautiful Qatar National Library, located at the heart of Doha's flourishing Education City.

Qatar National Library acts as a steward of Qatar's national heritage by collecting, preserving, and making available the country's recorded history. The Library provides equal access to all types of information and services and aims to enable the people of Qatar to positively influence society by creating an exceptional learning and discovery environment.

His Highness Sheikh Tamim bin Hamad Al Thani, the Amir of Qatar, officially inaugurated Qatar National Library on 16 April 2018. The Library was granted the status of national library under the Amiri Decree No.11 of 20 March 2018.

The programme will be comprised of keynote talks, panel sessions on key topics and valuable case studies outlining new developments relating to the development and implementation of Open Science policies and practices in research institutions and research communities across the Arab world. There will also be a series of expert-led workshops on core digital solutions relating to Open Science research.







## **Venue Information**

Day one of the 3<sup>rd</sup> Annual Forum (the 21<sup>st</sup> of October), will be completely online with no physical presence, so please do make sure to account for this when planning your trip.

The remainder of the conference days (22<sup>nd</sup> to the 24th of October) will be held inside the Qatar National Library in Doha, Qatar. The library is grand, has two main floors and is built circularly, so we've included a map of the premises to help get you where you need to be throughout the conference.

To reach Qatar National Library, we highly recommend that you use public transportation (such as buses, tram, or taxi) and avoid driving in yourself, as parking on site is extremely limited and could cause unnecessary delays throughout your experience.

When walking in, you will immediately be able to see the library's information desk, which is where you can always revert should you feel unsure about where you should go at any point in the programme. While we have partnered with Qatar National Library to use their space for the conference, it is important to note that the library will still be open to the public, and that not all areas of the library are reserved exclusively for the Annual Forum's delegates.

Please proceed to the conference registration desk to check yourself in and receive your name badge, which will be located in front of the special events area. The Welcome Ceremony and all major panels will be held in the Special Events Area, which can be accessed from the ground floor at the center of the library. Parallel panels will be simultaneously held in the Special Events Area and the Auditorium (which is located on the top floor). Please make sure to check the location of the panels you are interested in attending, and make sure to account for the time it may take to move from one space to the other. There are elevators and staircases that allow you to comfortably navigate between both spaces with ease.




The Annual General Meeting, which is an invitation only meeting, will be held in the Heritage Library in the basement floor, and all relevant attendees will be ushered there during lunch.

Located in the Minaretein building as a part of Hamad Bin Khalifa University's College of Islamic Studies (CIS), the mosque's architecture offers a reflection on knowledge and faith. Designed by Iraqi architect and calligrapher Taha al-Hiti, the minarets feature vertical calligraphy that sweeps upward, taking the viewer's eye heavenward in a contemplation of faith and meaning. The mosque is supported by five pillars, each representing one of Islam's pillars: Shahada (profession of faith), Salah (prayer), Zakat (giving alms), Sawm (fasting) and Hajj (pilgrimage).



There will be two tours, one in English and one in Arabic. The tour will be hosted right after the closing of our online programme on the first day, and will finish before the welcome reception.

## Workshops

#### Workshop 1- Building an Institutional Repository

#### **Description:**

This workshop, organized by the Qatar National Library Digital Collections Department, is a deep dive into the comprehensive process of building an institutional repository, from selecting a platform to configuring it for local needs, establishing metadata standards, and automating workflows. Participants will explore the development of the Qatar Research Repository Manara as a case study. The workshop will also cover key strategies for identifying and maintaining quality content, enabling digital preservation, as well as extending repository services to other local entities. Drawing on the QNL team's experiences, this session offers practical insights and lessons learned that will benefit anyone involved in or considering developing an institutional repository. Join us for an engaging session filled with real-world examples and interactive discussions.

#### Workshop Facilitator:

Dr. Arif Shaon serves as the Head of Digital Curation, Preservation, and Access at Qatar National Library. In this role, he oversees all aspects of the long-term digital curation and preservation of the library's digital collections. His previous experience includes significant positions at UNSW Library, University of New South Wales, Australia, and the Science and Technology Facilities Council, UK. There, he led software development and research initiatives focused on digital preservation, curation, and research data management. Dr. Arif holds a Ph.D. in metadata curation with an emphasis on long-term digital preservation.

Dr. Alwaleed Alkhaja is a distinguished professional with a rich and diverse career spanning intellectual property, academic publishing, and research. Currently serving as the Head of Open Access and Copyright at Qatar National Library, Alwaleed has been in this role since January 2023, demonstrating remarkable leadership in facilitating open access initiatives. In his role, Alwaleed oversees the Open Access Program operations and outreach; he is also part of the team that launched Manara – Qatar's Research Repository in 2023.



#### Workshop 2- Open Access Publishing Models: An Overview of Strengths and Weaknesses



**Rick Anderson** Birgham Young University, USA

#### **Description:**

This workshop will provide an overview of open access publishing strategies and the business models that underly each one. Participants will learn:

- the differences and similarities between various OA models
- the strengths and weaknesses of each
- which ones are more sustainable and which ones less so.

We will review specific examples of these models in action and assess their success thus far and their prospects for the future.

#### **Target Audience:**

Librarians and publishers who are interested in either supporting OA or undertaking an OA publishing project will benefit from this analytical overview of OA publishing models

#### Workshop Facilitator:

Rick Anderson is University Librarian of Brigham Young University. He has worked previously as a bibliographer for YBP, Inc., as Head Acquisitions Librarian for the University of North Carolina, Greensboro, as Director of Resource Acquisition at the University of Nevada, Reno, and as Associate Dean for Collections & Scholarly Communication at the University of Utah. He serves on numerous editorial and advisory boards and is a regular contributor to the Scholarly Kitchen.
